The boundary is drawn to include the area that supports the long-term survival of Arapien stickleaf and Utah fescue in this site. It includes the steep south-facing slopes below Red Pinnacle, where the two rare plants were found. It also includes adjacent similar habitat to allow for movement or expansion of the populations over time as landslides open up new sites, and existing sites become more heavily vegetated.
