The site encompasses steep rocky slopes and small cliffs south of County Road W. The lower land is generally dominated by greasewood (*Sarcobatus vermiculatus*), with sagebrush (*Artemisia tridentata*) on the rocky slopes, and rabbitbrush (*Chrysothamnus Greenei*) on areas intermediate between the two. Irrigated land occurs to the north and east.

Boundary Justification

The main threat to the rock-loving neoparrya would be physical disturbance of the habitat. The boundary was delineated to include the known extent of the plant population and enough of the adjacent area to incorporate portions of other habitat types. This additional habitat was included based on the assumption that pollinators of the rock-loving neoparrya may also require other types of habitat. The pollinators are unknown, consequently we are not certain that the amount of adjacent habitat is sufficient to support those species. With more information, these boundaries may change.
